Health awareness program:

- Communities have greater access to health services through RHPs and Health Camps; especially the women and old aged people who face accessibility issue to seek medical treatment. 2857 people have accessed treatment this year through RHPs, 585 through Haat Bazar Clinics and 130 through Health Camps under Arogya Project of BALCO CSR run by SROUT.
- Enhanced collaboration and joint intervention with health department
- SROUT have reached 1899 truckers and migrants through our ICTC counseling, Outreach counselling and Canopy camps for HIV/Aids Awareness.
- 18660 community people reached with HIV/AIDS prevention and control messaging
- Communities, VHSNCs and MAS are sensitized on the sensitivity and control of the disease.
- Mothers are educated and practicing health seeking behavior like ANC visits, IFA consumption, diet diversity, improved IYCF practices observed during the home visits
- Increased consumption of the THR and replication of the recipes to feed the
 Children. 643 mothers are trained on THR recipes to directly address malnutrition

- Good acceptance of the Poshan Badi intervention among the beneficiaries in terms of practice and consumption. 150 families have been benefitted under this intervention
- Improved status of malnutrition (Based on MIS data of PD Hearth) under Arogya Project
- Arogya Project has conducted 25 PDH sessions in FY23 through which total 411 children benefitted
- Enhanced the knowledge of the stakeholders on HIV/AIDS preventive behaviors and control mechanism, Govt services etc
- Effective awareness sessions for the Truckers and Migrants to discuss the sensitivity of HIV/AIDS, counseling and testing facilities
- Greater reach to the communities with HIV/AIDS control messaging through group meetings, Canopy camps, audio/video messaging etc
- 680 community people are educated on prevention and control of TB who will act as change agent
- Enhanced the knowledge of the stakeholders on TB preventive behaviors control mechanism and Govt services
- We have educated 229 mothers on THR consumption and ensuring the behavior change at the household level. This would help the malnourished children to improve their nutrition status

Child and women rights and protection-

- 3 Panchayat were identified for Making a Child Friendly Panchayat with support of UNICEF.
- 3 BAL SABHA, 3 WOMEN Sabha, 3 Bal Mela and Sports fest were organized in 3 Village panchayat of Janjgir champa and sakti district of Chhattisgarh.
- Total 390 cases handled related to children by the team Child line. Total Cases handled from Inception are 3832.
- 36 children given shelter at children home run by organization in support of WCD. From the inception of the project the SROUT covers 172 children for shelter.
- 26 women and 6 children given shelter at Ujjwala home run by Organization SROUT.
- Inauguration of Chhattisgarh's first Child friendly panchayat was done by honourable speaker Chhattisgarh legislative assembly Dr, Charan Das Mahant on dated 16th November 2023, In presence of Mr. Job Jakaria Head UNICEF Chhattisgarh.
- To celebrate the happiness of children's and for creation of mass awareness about the child friendly panchayat 3 bal mela was organised in all the three panchayat of Sakti constituency of Janjgir Champoa and Sakti District of Chhattisgarh.
- GOING Blue program was observed in 3 Panchayat's.
- 3 Training programs on GPDP was organized in Balpur, Darang and Jongra Panchayat for PRI members and for Yojna Gathan Dal. In this program the participants were informed about the child rights, children's issues in the villages and about the GPDP of child friendly panchayat.

- 3 Bal Sabha Program was organised to understand the issues and problems of children in all the three panchayat Balpur, Jongra and Darang. During the program the participants were informed about the child rights and good touch bad touch.
- 3 Mahila sabha was organized to understand the issues and problems of women in selected panchayats.
- Child friendly GPDP of the 3 selected panchayat was prepared.
- Training of Volunteers for HH survey and Paheli survey was conducted at Balpur, Jongra and Darang Panchayat.
- HH survey was conducted in Balpur, darang and Jongra Panchayat with 100 samples in each panchayat.
- Paheli survey was conducted in all the three panchayats.

Women Empowerment -

- Under the Watershed development program of NABARD nurtured and handholding support to the 35 Self-help groups.
- SROUT has formed more than 1000 Self help group from the inception of the organization.
- More than 1000 women got training of skill development and associated with the livelihood activities.
- Two SHG's (self-help groups) were provided with tent material for the work of tent house
- Two SHG's (self-help groups) were provided with Rice mill for the work of Paddy processing.
- One SHG were provided boutique shop.
- One SHG were provided grocery material for open a grocery shop for the livelihood support of women.

Soil and Water Conservation (Watershed)

- Main Phase of Songudha watershed started. Total around 1000 hactare land will treat for soil and water conservation.
- More than 14000 Hectare land was treated in our previous project Parsakhola watershed project.
- More than 800 Families benefitted from the Parsakhola watershed program.
- In the year 2022- 23 around 240 beneficiaries benefitted with different activities of Soil and Water conservation and climate proofing activities.
- SRI, Organic Farming, DRIP Irrigation, Farm Pond, Paddy Bunding, Contour Bunding has been made in Aurakachar, Songudha, and Dondaro Village of Korba district.

Sanitation and cleanliness -

- Awareness program on Sanitation was conducted with the help and support of PHED (Public Health and engineering department) Janjgir Champa distict of Chhattishgarh state. Total 81 Panchayat and 109 villages covered.
- Awareness program on Sanitation was conducted with the help and support of PHED (Public Health and engineering department) KORBA distict of Chhattishgarh state. Total 35 Panchayat and 49 villages covered.

Farmers Producers organization -

- More than 500 Farmers associated with the Nav kisaan farmer's producer's organization nurtured by the organization. This year more than 800 Farmers benefitted from the FPO Activities.
- Farmers producer's organization input shop is shifted to the new building constructed by the Balco CSR for FPO.
- The Input shop of Farmers producer's organization was inaugurated by the Head Balco CSR Ms. Monika Jain.

District Administration through their health department awarded for best implementation in the field of malnutrition and maternal and child health.

VISION

Our vision is a society in which people live lives with dignity, prosperity and happiness.

MISSION

Our mission is to end poverty by empowering the marginalized and vulnerable sectors of the community; providing them with the capacity to take ownership of their own development. Therefore, women and children are at the forefront of our work, as we address issues related to health and hygiene, education, the environment, gender empowerment, rehabilitation and resettlement, and livelihood promotion.

Project Details

Arogya project —. Project Arogya is a health project on health implemented by SROUT support of Balco CSR. The project aims to target areas of issues in health care and supports the community with interventions in Primary Health



in

Care, Awareness on various seasonal and non- seasonal diseases. Specific emphasis is laid on Malaria, TB, HIV and Maternal & Child Health in order to create a community which is free from diseases and can lead healthy and prosperous lives.

The program has been implemented in Balco's plant location, actively covering 26 core villages & Urban slums covering over 35000 people. The introduction of Arogya in these areas in relevant as most of the villagers had to travel a great distance to avail medical facilities, also the medical facilities used to cost a significant amount which is more

than what rural population could afford. After the introduction of Rural Health Posts the health care services have become both accessible and affordable.

Child line 1098 – ChildLine is a national 24-hour free emergency phone line which can be reached by dialing 10-9-8. The program also does outreach in order to find, rescue, and support children in need of care and protection. Established by the Women and Child Development department in 1996, the program was piloted in Mumbai. It is now present in 366 cities across 34 states in India. SROUT is the implementing agency for the ChildLine branch in Korba, Chhattisgarh. SROUT's ChildLine staff members respond to cases of abuse, children in conflict with the law, and reports of child trafficking, missing children, or runaway children, as well as other unique situations of which they are made aware. They are responsible for ensuring that children in need of care and protection receive the help and support that they need. Around 390 cases handled related to children by the team Child line in the year 2022-23.

Child home boys— Under integrated child protection scheme Balgrih boys was there in which 40 children were there under 6 to 17 age. The Child Home for Boys is a shelter for male children who are in need of care and protection. This may include children without parental care, runaway children, migrant children, and child substance abusers. Started in 2013, it has the capacity for up to 50 children, providing accommodation, basic, care, as well as counseling and support as needed. The home works closely with the local Child Welfare Committee to respond to each unique case, determining the best and most caring option for the child, with an ideal of reintegrating the child with their family if is possible and reasonable. This year we have given shelter to the 36 children of organization.

Ujjwala: The trafficking of women and children for commercial sexual exploitation is an organized crime that is on the rise in India. Ujjawala is a national scheme established by the Ministry of Women and Child Development that works to prevent human trafficking and provide rehabilitation. and rescue. integration services to victims of trafficking. SROUT has been the implementing agency for the Ujjawala scheme in Korba district since 2013, with focused efforts on two key aspects of the scheme:



prevention and rehabilitation. This year 26 women and 6 children got benefitted from our program

Farmers producer organization

The Farmer Producer Organization (FPO) is an initiative to assist small and marginal farmers in accessing inputs, investments, technology, and markets by mobilizing them to leverage their market aggregate market power. Through collective action, farmers are able to enhance productivity through efficient, cost-effective and sustainable resource use. They attain a higher market value for their produce by controlling a larger market share. The combination of these two factors leads to significantly higher returns for their labor and production. SROUT supports an FPO in Bhatgaon village of Korba district. Farmers producer's organization input shop is shifted to the new building constructed by the Balco CSR for FPO.

The Input shop of Farmers producer's organization was inaugurated by the Head Balco CSR Ms. Monika Jain.

Watershed project -



Agriculture is a primary income source for approximately 80% of Chhattisgarh's inhabitants. The majority of these farmers rely on rainfall and traditional methods to cultivate their produce. As a result, agricultural communities are highly vulnerable to unpredictable weather patterns, such as flooding and drought.

The Watershed Development Program is designed to improve soil quality and water conservation through earthen structures that slow down the movement of rainwater through an area as well as water storage strategies that provide irrigation sources for dry months. Though facilitated by SROUT staff and funded by NABARD, this is a village-led program, with community members making decisions and providing labour to implement water management strategies.

Currently, SROUT is supporting a watershed development project in the Songudha watershed, encompassing the Songudha, Aurakachar, and Dondaro villages. April 2022 is a month to start main phase of songudha watershed project. From April 2022 Project Activities has been started and Farm Pond, Paddy Bund, Contour Bund, Plantation, DRIP Irrigation system

installation, organic farming, SRI and Many Self-help group income generation activities been started in year 2022 – 23.

Putting Children at the centre: **Strategic Advocacy for Child Rights** in Chhattisgarh - An Advocacy program for Child rights name Putting Children at the centre: Strategic Child Advocacy for Rights Chhattisgarh has been introduced in Janjgir Champa and Sakti District of Chattisgarh. 3 Village Balpur, Darang and Jongara has been selected for the initiative and primary activities like sensitization on issues of child rights has been organized in all the three



village panchayat with the stack holders and PRI members.

Support on Pulse Polio Immunization Program- Immunization camps were organized at 6 places of Korba which includes Niharika chowk, ITI Chowk, Ghantaghar Chowk, CSEB Chowk, Transport Nagar Chowk, Darri Bazar and more than 300 children given pulse polio vaccine through our posts.

Awareness Programs on National Days — National womens day, World AIDS day, Environment day, Immunization day, Malnutrition week, Menstrual hygine day etc were commemorated aiming awareness to the community.
